Facts found:	<ol style="list-style-type: none"> 1. The sailing instruction C4 describes three possible finish lines. 2. The last part of the course board on the race committee vessel indicated “V40” and “finish”. 3. There was no visible finish line at or to windward of mark V40. 4. A finish line was laid according to SI C4.3 in the harbour. 5. There is no evidence that any boat did not round mark V40. 6. The boats proceeded towards the harbour. 7. Some boats, including mermaid IV requested clarification via VHF on the location of the finishing line. The race committee responded, giving details of the position of the finish. 8. As boats approached the harbour, some boats proceeded immediately to the finish, other boats started to sail towards their moorings and then later sailed to the finish line. 		



9. The race committee recorded the boats as they crossed the finish boat. Only three boats were recorded as DNF.

10. After racing, the race committee published an amendment making the “harbour finish” the default finish.

Conclusion:

1. There was an improper action of the race committee in not designating clearly, before the warning signal, the finishing option that they intended to use as required by rule 27.1.

2. All boats except three, finished correctly by complying with SI C4.3 and the definition *finish*.

3. Three boats did not cross the finishing line and were correctly scored DNF.

4. The improper action of the race committee did not remove the obligation of the boats to sail the course and finish.

5. No boat’s score was made significantly worse, through no fault of their own, as a direct result of the improper action of the race committee.
